

A. Statement of Intentions

Whereas CDAC(T) is a Scientific Society under the Ministry of Communications & Information Technology, Govt. of India, executing a number of projects directly for the Government and the Defense.

Whereas **LMCST** is a premiere academic institute in the country with academic expertise in the field of Computer Science and Masters of Computer Applications at PG level. The institute also offers UG programmes in Electronics & Communication, Computer Science, Electrical & Electronics, Mechanical, & Civil Engineering.

Whereas LMCST needs support from CDAC (T) in the following areas:

- (a) Expert lecture in embedded systems, VLSI Design, Signal Processing,
 Cyber Forensics, Information security & Power Electronics.
- (b) The invited talk, seminars, workshops in the field mentioned above (a)
- (c) Short term training & industrial visits for LMCST staffs & students at CDAC (T) or LMCST premises with prior notice.
- (d) Allowing final MCA/MTech/BTech students to do project work at CDAC premises/providing guidance to project work at LMCST campus.
- (e) Guidance and support for executing projects undertaken by LMCST.
- (f) Undertaking collaborative projects from other agencies and executing them.

Though this MoU, CDAC (T) and LMCST agrees the terms and conditions given herein after.

B. Terms and Condition

Scope of Work

CDAC (T) is currently executing a number of R&D projects under various project heads in its development center at Trivandrum.

CDAC (T) has expertise in numerous areas of Electronics, Communication, Computer Science etc. In the field of Embedded Systems, Power Electronics, Signal Processing, Cyber forensic, Information security etc. CDAC (T) develops and delivers a number of projects.

CDAC (T) can support LMCST for the modules detailed below:

Module 1: Expert lecture: Experts from CDAC(T) can deliver expert lecture in the areas of Embedded Systems, Signal Processing, Cyber Forensics, VLSI Design, Power Electronics, Information Security etc. as mentioned in part(a) of Section A or related fields to suit the requirements of BTech/MTech programmes being run at LMCST.

Module 2: Invited Talk: LMCST will require various invited talks for conducting seminars, workshops in the academic year from time to time. CDAC (T) will be able to provide staff for delivering the lectures in various areas particularly mentioned in Part (a) of Section A at LMCST premises.

Module 3: Staff and Student Training, Industrial Visits: LMCST will require state of the art technology updation and skill improvement in various fields particularly in the areas mentioned in part A of Section A. CDAC (T) will permit identified and selected faculty and students from LMCST to undergo short term training & industrial visits at CDAC (T) premises. The training and industrial visits will give LMCST an exposure on latest trends in concerned filed and its application.

Module 4: Sharing R & D projects: CDAC (T) runs a number of large projects for the government, defense, etc. CDAC (T) can consider collaborative projects which can be executed at LMCST Labs/CDAC(T) facility.

2. Type of Agreement

This is an umbrella agreement covering all the modules 1 to 4 noted above. Specific agreements with terms and conditions of the same can be made as per the requirements through MoA.

3. Responsibility

CDAC will provide support for Module 1 to 4. CDAC will charge fees for project work and other trainings on a concessional rate after discussion with LMCST from time-to-time. For the expert lecture and invited talks the expenditure will be borne by LMCST.

LMCST will provide coordinating work for attaining module 1 to 4. LMCST will ensure that at least two batch of students will be send to CDAC for projects and industrial training.

4. Consultancy /module charges

The related consultancy/module charges will be as per the specific agreement of the modules agreed upon.

4.1 Project Review

In the case of projects, a module review committee constituted (members mentioned below) by CDAC (T) and LMCST will review the progress of the modules at specified intervals (once in 3 months).

4.2 Contact persons from each side

- 4.2.1 There will be a contact person of appropriate designation from CDAC(T).
- 4.2.2 There will be a contact person from LMCST also at least at the level of an Assistant Professor.

4.3 Project Schedule

The project schedule will be decided by CDAC (T) and LMCST based on the modules.

4.4 Budget

The budget for the module / project will be as per the specific agreement of the particular modules concerned.

4.5 Payment

The payment will be as per the terms mentioned in the specific agreement of the specific or particular module(s) (including the applicable / respective taxes).

5 Intellectual Property

All prior information, design & data existing with either party before the start of this (free existing IP) shall be the sole property of that party. All intellectual property including design information, designs & data generated through the project shall be held jointly by CDAC(T) & LMCST. Any commercial utilization of

the IPR will be discussed and mutually agreed upon between CDAC (T) & LMCST before being executed.

6 Validity

Validity of the contract is for 12 months from the date of signing of this MoU. This will be reviewed for renewal at the expiry of the contract.

7 Arbitrations

In the event of dispute or difference of any nature whatsoever between the parties during the course of performance of respective obligations arising out of this agreement, the parties agreed to refer the matter to the Heads of the Institution resolve the disputes keeping in view the best interest of the parties and in keeping with the spirit of performance of this agreement.

If the matter still remains unresolved, then the same may be referred to International Centre for Alternative Dispute Resolution (ICDR) for arbitration in the event of dispute instead of going to the courts directly.

8 Jurisdiction

The parties to this agreement hereby declare that in case any dispute is to be resolved by resort of arbitration, the seat of the Arbitrator shall be within the territorial limits of the district Court, Thiruvananthapuram.

9 Force Majeure

Neither party shall be liable to the other for any delay or failure on their part in performing any of their obligation under this agreement, resulting from any cause beyond their control including, but not limited to strikes, fires, floods, earthquakes, explosions, riots, acts of God, acts of Government, war, enemy action or political changes.

10 Termination

Both the parties have the right to terminate the agreement by giving a prior notice not less than 3 month.

NOW THEREFORE THE PARTIES HEREBY ACKNOWLEDGE AND AGREE AS FOLLOWS:

- The parties, their representatives, and/or assignees, following the execution of this MOU, desire to maintain close contacts with each other to achieve the goals and objectives of, and to develop the ideas acknowledged in this MOU.
- Both parties hereby agree to designate a representative from its side who will be the primary point of contact on behalf of that party.
- Any expenses incurred by the parties for the purpose of this MOU shall be agreed upon and shall be borne as per the mutual agreement.
- 8. Notwithstanding any other provision of this MOU, neither party shall have any right to use any trademarks or trade name of the other party, nor to refer to this MOU or the obligations performed hereunder directly or indirectly, in connection with any product, promotion, or publication without the prior written approval of the other party
- All information which has been disclosed to or obtained by either party at any time during the implementation of this MOU, is confidential information. For this purpose, the parties agree to sign the binding non-disclosure agreement in Annexure II.

10. The terms and conditions mentioned herein shall commence on the execution of this MOU and shall continue for a period of two (2) years from the date thereof or for such period as may be determined or extended by the parties from time to time by written notice, unless terminated by either party in accordance with this MOU. Either party may terminate this MOU at any time by providingthree (3) months written notice to the other party.

- 11. Any notice required to be given hereunder shall be in writing and shall be deemed to be sufficiently served on the party if sent by hand or by registered post to the addresses of the party as stated in this MOU. Notices shall be deemed received: -
- (i) If sent by registered mail, three (3) days after posting;
- (ii) If by hand, on the day of delivery; and
- (iii) If sent by telex or facsimile to the correct number or designated address within seventy-two (72) working hours.
- 12. Both parties agree to take all reasonable steps to ensure the successful completion of the collaboration, and co-operate with each other in duly carrying out the obligation agreed upon.

Save and except for Clause 6, Clause 7 and Clause 8, this MOU is not a legally binding contract and under no circumstances does this MOU subject either of the parties to liability for breach, whether material or minor, of contract or any other liability under international law or the laws of the country of the respective parties or any other applicable law.

19. The parties hereby agree that they are not bound exclusively by this MOU and are at liberty to enter into any separate agreements or arrangements with any third party without reference to the other party.

The Recipient may be given access to the Disclosing Party's Confidential Information or to create new Confidential Information for the Disclosing Party.

In view of the above, the parties agree as follows:

1. Confidential Information

"Confidential Information" includes any information:

- specifically indicated by the Disclosing Party, either verbally or in writing, as confidential;
- under the circumstances of the disclosure, that are to be treated as confidential; or
- the Recipient creates or produces while performing its obligations under this Agreement, regardless of the media that contains the information.

Confidential Information does not include information, which:

- is generally available to the public at the time of its disclosure to the Recipient;
- becomes known to the public through no fault/action of the Recipient in violation of the terms herein;
- is legally known to the Recipient at the time of disclosure by the Disclosing Party;
- is furnished by the Disclosing Party to third parties without restriction; or
- is furnished to the Recipient by a third party who to the Recipient's knowledge legally obtained said information and the right to its disclosure.
- is developed independently by Recipient without use of or reference to the Disclosing Party's information.

2. Restrictions on Use

1. Visit to Infosys Ltd. Trivandrum Campus








Report Industrial Visit - Muralya Dairy

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:






20 September 2019 - Lunch with Chairman

23 September 2019 - All Kerala Maria Philip Memorial Debate Competition


